You are cordially invited to attend the St. Kitts and Nevis Christmas Regatta (SKNCR), being held at Spice Mill, Cockleshell Bay, on December 4th 2021. Competitors, coaches and their families are welcome before, during and after these dates. The Organizing Authority (OA) is the St Kitts Yacht Club Limited operating as St Kitts Yacht Club (SKYC).

1. **DEFINITIONS**

1. The notation '**DP**' (Discretionary Penalty) in a rule in the NoR means that the penalty for a breach of that rule may, at the discretion of the protest committee, be less than disqualification.

2. RULES

- 2.1. The races will be governed by rules as defined in The Racing Rules of Sailing (RRS) 2021-2024, https://www.sailing.org/tools/documents/ RRS20212024Finalwithbookmarks-[27255].pdf)
- **2.2.** This Christmas Regatta will be conducted in accordance with St. Kitts and Nevis and Nevis Island Administration laws, regulations, policies and requirements regarding the Covid 19 pandemic, including cancellation, postponement and abandonment of the regatta or individual races.
- **2.3.** Any prescriptions of the St. Kitts and Nevis Sailing Association apply and can be seen at: (http://www.sknsa.org/events.html).
- **2.4.** Coaches shall not interfere with other boats, subject to jury disqualification from the regatta. (DP)
- 2.5. In weather requiring all boats to return to harbour or for other safety issues, all boats (Race Committee (RC), Safety, coaches) boats come under the direction of the RC and shall render assistance as directed including towing any participants back to shore. Spectator boats are encouraged to help (see SIs for more information)

3. ADVERTISING

3.1.Boats may be required to display advertising chosen and supplied by the **OA**.

4. ELIGIBILITY

4.1.Entrants must be members of a Yacht Club recognized by their National Sailing Authority or a member of their Class Association. All boats and equipment must conform to their respective class and/or fleet measurement, equipment and accommodation regulations. (DP)
